- H. Due to issues described above Secretary-Treasurer MacCrory has requested proposals from other payroll agencies to bring to the trustees for a potential change.
- I. The Local's current Pension payroll service Advantage (subsidiary of Paychex) will no longer file the required tax forms required after December 31, 2022. Secretary-Treasurer MacCrory presented a proposal to the trustees for one of the few companies that submits required pension filings; which has been tentatively approved upon the proposal for our other payroll services.

- A. The Board reviewed the membership report. President Gardler requested a column at the end of the report reflecting the cumulative membership that is broken into categories on the report going forward.
- B. Secretary-Treasurer MacCrory has been working with National to customize their membership database to reflect our Local's unique structure with Units and Branches. She presented the Board with instructions on how to pull membership reports by Unit and Branch.

6. District 2-13:

- A. The grievance manager is not working. Western Region Vice President Bialek will send President Gardler the details and he will reach out to Mike Davis, Assistant to the District 2-13 Vice President for resolving and streamlining the platform.
- B. Jim Ryan, CWA District 2-13 Staff Representative joined the meeting via conference call. He gave updates on mediations and arbitrations being scheduled this week. One case is waiting on a potential settlement with Verizon labor. The Lego arbitration has been heard and the District is cautiously optimistic.
- C. CWA District 2-13 Staff Representative John Remington joined the Executive Board meeting via conference call. He gave an update on CWA Strong and the Civil Rights and Equity Committee. This quarter the committee will put together a report and a 10:1 steward structure, which doesn't necessarily make sense for Local 13000. He reported that Western Region Vice President Bialek has been a huge help in bargaining. Breezeline bargaining already had two bargaining sessions with two more scheduled before expiration next month and the Comcast Alle-Kiski contract expires in May. He gave updates on current cases in the District: the Arbitration for Gary Patchel is in progress and the District is cautiously optimistic. Remington recommended the grievance against Comcast for improper call out pay to move forward in Arbitration. The arbitration for Trevor Miller with Consolidated has been withdrawn. There are two appeals received, one has been denied the other is still in review. He gave the Local a huge thank you for their generosity towards the strikers against the Pittsburgh Post-Gazette during the holiday season.
